

## **Zvia MedSpa Morpheus Giveaway**

### **Official Rules**

#### **1. Eligibility**

The Zvia MedSpa Morpheus Giveaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. However, winners outside of Colorado must be willing to travel to the Zvia MedSpa location in Lakewood, Colorado to receive treatment. Employees of Zvia MedSpa and other companies associated with the promotion of the contest and their respective parents, subsidiaries, affiliates, and advertising and promotion agencies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The contest is subject to federal, state, and local laws and regulations.

#### **2. Sponsor**

#### **3. Agreement to Official Rules**

#### **4. Contest Period**

The Contest begins on August 01, 2022, at 8:00 AM Mountain Time and ends on September 30, 2022, at 5:00 PM Mountain Time (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. The

**5. How to Enter Online:** This method of entry will be available by visiting our website's 2022 Promotions Page, and following the directions provided to fill out the entry information and submit. Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

**6. Prize Drawing** On or about September 30, 2022, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winners via telephone or email on or about August 31, and September 30, 2022. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

**7. Winner Notification** The potential winners will be notified by email, mail or phone. Each potential Prize winner will be required to have contact within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted or fails to respond within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize.
